Guidelines for Vendor Booth Exhibits

1. **Audio Equipment:** Playing of any type of audio equipment is prohibited.
2. **Food:** Cooking, or selling of food is prohibited.
3. **Refunds and Returns:** A posted sign is required stating your policy of non-returnable products.
4. **Taxes:** Exhibitors may be required by the State of Texas to pay a state sales tax of **.0825%** of all sales receipts.
5. **Logos and Trademark:** You are prohibited from using or selling items which bear the name, logo, or mark of “MBGCT” Annual Session 2026 or any variation.
6. **Cancellation policy:** All pre-registered Exhibitors who desire to cancel must send a written notice prior to **July 18, 2026** which is ten **(10)** days, before the State Congress begins. A **\$60.00** service fee will be retained. There will be **NO** refunds issued after **July 18, 2026**.

Violation of these rules will result in the forfeit of fees, and exhibitors will be asked to immediately vacate the premises by authorized personnel.
