Guidelines for Vendor Booth Exhibits

1. The Exhibit Area is the only location for booths or exhibits.
2. All exhibits can be set up as early as **Monday morning, October 19, 2026** after **9:00 a.m.**, and must be dismantled by **3:00 P.M., Thursday, October 22, 2026**.
3. Playing of any type of audio equipment is prohibited.
4. Cooking and selling of food from the booths is prohibited.
5. A posted sign is required stating your policy for non-returnable products.
6. You are prohibited from using or selling items that bear the name, logo, or mark of "Missionary Baptist General Convention of Texas" unless approved by the Convention officials
7. Additional tables, racks, and chairs, may **not** be used to set up another booth unless previously paid for and recorded by the Host Committee Team. Any additional equipment or fixtures must be contained within your allotted space.
8. Cancellation policy: All pre-registered Exhibitors who desire to cancel must send a written notice prior to **October 9, 2026** which is ten (10) days, before the Convention begins. A **\$50.00** service fee will be retained, for all cancellations, and a **\$35.00** charge will be assessed for all returned or **NSF checks**. There will be **NO** refunds issued after **October 19, 2026**
